Call to Order: The meeting was called to order at 7:01 p.m. by Cheri Belkowitz

Agenda & Minutes:

- Connie presented the minutes. Corrections were made to attendance and to clarify a statement that was made about the term limits for the Chair. Susan motioned to approve the December minutes as corrected. Joanne seconded. The motion passed unanimously.
- Connie introduced the agenda for the meeting. The agenda was accepted as presented.

Public Comment

- Shannon Duncan spoke about dyslexia and her experience in FCPS with her daughter. She is a founding member of Decoding Dyslexia Virginia. She feels like improvements have been made in identification via iReady, but there is more to do. Delivery of services is not consistent because teachers are not receiving the training they need and programs available to FCPS schools are not used consistently. Access to Assistive Technology is too limited. Parents do not trust that FCPS is doing their best and feel like their children are an afterthought. Ms. Duncan distributed a "state of the union" dyslexia packet to ACSD members. Cheri is noted that she is speaking at a conference on dyslexia at Longwood University on April 25
- Jenna Gould, a student, spoke about her previous school and how the treatment of students and staff impacted her schoolwork and emotional health. Her new school placement has improved her self-esteem and educational performance.

Parent Resource Center News:

- Mary Beth Harrison-Cunningham, Director of the PRC, provided an update. The PRC has again applied for a grant from the Department of Education to keep hourly staff for the summer. The PRC will offer the parent/child Mind in the Making series in the summer (5-8 year olds). They will teach 2 skills per week via modeling and activities in the PRC library. The PRC also plans to hold its Educator Lunch and Learn series for teachers to learn and network. In April, there will be a collaboration with Fairfax County for Child Abuse Prevention month. Special Education conference registration will be opening soon, hopefully Friday, February 14. Sign up for News You Choose and use social media to keep up with the PRC.
- Ann-Marie thanked the PRC and Ombudsman's office for coming to speak to community groups, such as when they presented to PTA members in the Justice pyramid.

- There was a question about whether transportation would be offered for the Special Education conference. No answer was available.
- There will be a student strand at Special Education conference (not I'm Determined but similar themes).
- Stella Pekarsky, the new School Board liaison from Sully District, introduced herself. The School Board will be undertaking an independent audit of special education in FCPS.

Presentations:

- Dawn Schaefer, from the Office of Due Process and Eligibility, gave a presentation on
 Eligibility Basis for Committee Decisions (BCDs) forms. Students must meet the criteria on
 the BCD form in order to be eligible for special education. Changes to the forms were made
 to bring them in line with Virginia forms. A statement was added about medical diagnosis
 not being sufficient to determine eligibility. The language about specially designed
 instruction was clarified.
- The forms for all 14 categories are available on FCPS Special Education Forms page under the Eligibility section. A summary of the changes is noted below
 - Autism: does not need to have documentation for PDD, criterion A (must meet all), criterion B (must meet one)
 - o ED: moved social maladaptive statement
 - Hearing Impairment: 4 types of hearing loss (must meet one)
 - o ID: document specific instrument for intellectual functioning and adaptive functioning, age of onset, rule-outs added limited English proficiency
 - o Multiple Disabilities: examples changed, multiple labels vs. MD
 - Orthopedic Impairment: removed one or more instructional areas because it was repetitive
 - o OHI: no changes
 - SLD (most common eligibility category): criteria B was moved to criteria A; spelling was added for underachievement; added to processing: long term recall, rapid naming, working memory; evaluation outcomes: discrepancy model, response to intervention, patterns of strengths and weaknesses; must document adverse effect on educational performance
 - o SLI: significantly "discrepent"
 - o TBI: sensory and perceptual abilities separated
 - Visual Impairment: no changes
 - o DD: no substantive changes, adverse effect on age appropriate activities
 - Deafness: types of hearing loss
 - o Deaf-Blindness: no changes
- Trained all local screening committees
- Categories convey information as the starting point any service is eligible to be given, services and supports are not category dependent

- Education is more than academics
- Cheri noted that there are limitations to technology (CSTARS) that prevent teams from typing all the information in
- State Parent Handbook has information about eligibility and the categories
- FCPS Parent Handbook is still in process
- Questions: Dawn Clements, Office of Due Process and Eligibility, PSLs, Special Education Department Chair
- Stefan Mascoll from the Office of Bullying Prevention and Intervention gave a presentation about bullying.
- SR&R definition of bullying via VDOE: behavior is repeated; intent to harm, embarrass, hurt another student; power imbalance must be present (size, age, number of students). If the interaction is something other than bullying, the school will address it and not label it as bullying
- Educate students about bullying before it happens: SR&R review at beginning of the year, then mid-year; video for 7-12 (bullying, harassment, substance abuse) elementary level is lesson provided by their teacher. Educational lessons by counselors via school need, classroom or school wide. Bullying lessons are not mandated but harassment lessons are mandated, so many counselors just incorporate bullying into that. Health and PE classes have bullying component, via healthy relationships. There is not one mandated curriculum that FCPS uses. Each school has its own culture. There is not a particular effort to prevent or educate about bullying students with disabilities. All students are encouraged to advocate for themselves or others. Students with disabilities: if unfounded, IEP case managers are notified. If founded, an IEP meeting is convened.
- What is the school's response? BHMS (administrators only, 5 years only) captures detailed notes of allegations of bullying and harassment; SIS captures all incidents that are determined to be in violation of the SR&R. Parents can request the information from BHMS but it would be redacted. Administrator must investigate the allegation, speaking to students, parents, teachers, viewing video. After collecting information, administrators determine if it meets the definition of bullying. By Day 4, parents should have an update. The BHMS captures the school response and attempt to resolve the issue. Parents should receive a summary letter and phone call from an administrator. There should be an attempt to collaborate. School administrators don't always follow the procedures. Complaint (parent not satisfied with resolution) vs. appeal (for students who have been suspended). Speak to the administrator in charge of investigation. Then go above the administrator (most likely to principal). Then go to the region assistant superintendent.
