... as well as the primary retirement benefits provided by the **VRS**, plus a review of **FCPS healthcare insurance options** in retirement.

The evening Pre-Retirement workshops are provided **only** for ERFC and/or VRS members who are within two years' eligibility for retirement.

You are eligible for *full* retirement benefits under the **ERFC Legacy Plan** structure...

- At age 55 with 25 or more years of credited service
- At age 65 with 5 or more years of credited service

You are eligible for *reduced* retirement benefits under the **ERFC Legacy Plan** structure...

- At age 45 with 25 or more years of credited service
- At age 55 with 5 or more years of credited service

You are eligible for retirement benefits under the **ERFC 2001 Benefit Plan** structure...

- At age 60 with 5 or more years of credited service
- At any age with 30 or more years of credited service
