

## FAIRFAX ACADEMY/FHS PARKING AGREEMENT 2008-2009

If a student does not have a parking permit from their base school, the cost of a Fairfax Academy parking permit is \$50.00 (Fifty Dollars) per school year. The parking permit will only be valid during their specific academy block (AM, MD, PM) and will not be accepted on school grounds at their base school.

### Fairfax Academy Parking Permit Fees Are Non-Refundable.

Parking Permits are non-transferable but may be shared with an approved carpooler (must register with the academy office and security and receive an individual parking tag for their vehicle.

**Privileges:** The purchaser of a Fairfax Academy parking permit will be assigned a numbered parking space that will be reserved for their use during their specified block (Depending on the block that they attend) on days that school is in session. Students are encouraged to carpool and one parking spot can be used for more than one car as long as both drivers and their vehicles are registered with the Academy office and an Academy parking tag is issued.

### **Rules:**

- All Students must display an Academy and an FCPS registered parking permit at all times to park on Fairfax High School grounds and have administrative permission.
- Students must abide by the posted speed limit on school grounds, (15 mph) as well as maintain control of their vehicles on school grounds, and abide by the Va. State passenger limits. Students must also observe laws such as stopping behind busses with flashing lights, yielding to pedestrians, and not recklessly endangering themselves, other students, or the faculty of Fairfax High School on their way to and from school.
- Students are not allowed to paint or decorate their assigned parking spaces.
- Students are not allowed to return to their vehicle or leave school grounds during their assigned academy block unless they have written permission and/or have properly checked out through the academy office.
- Students are not allowed to have illegal items in their vehicles while on Fairfax High School grounds. Such items include weapons of any kind, narcotics, intoxicants and alcohol, controlled substances, or tobacco. Any vehicle on Fairfax High School grounds with reasonable suspicion of containing any illegal item will be subject to search and seizure (provided by section E of the Fairfax County Public School Regulation 2601.15, of the Students Rights and Responsibilities).
- Students are discouraged from storing valuable items in their vehicles and asked to keep their vehicles locked while on Fairfax High School grounds. Expensive car stereo equipment should be safeguarded with a car alarm. Fairfax High School is not responsible for stolen items.
- **Students may only park in their registered space at all times.** If an unauthorized vehicle is in a students registered space that student must come to the Security Office where a temporary space will be provided. Students should not take personal action against the unauthorized vehicle.

**Penalties:** Any violation of this parking agreement may result in loss of parking privileges for all persons registered to that vehicle or parking permit without refund of permit cost. Any vehicle on school grounds without a valid Fairfax Academy Parking Permit may be "ticketed" or "booted" and assessed a fine of \$50.00 (Fifty Dollars). Vehicles with multiple parking violations will be towed off school grounds at owners' expense.

This parking agreement serves as notification of the parking rules and there will be no other warnings prior to the correction of parking violations. Unauthorized leaving of school grounds will result in loss of parking privileges for all vehicles registered to the permit for the remainder of the school year (without refund of parking permit cost). Excessive tardiness to any block class due to driving will be grounds for temporary suspension of Fairfax Academy parking privileges until tardiness improves. Removal of Parking Permit may be an option for the Fairfax High School or Academy Administration in student cases of Chronic Disciplinary Disruption. **Students will be charged in a Court of Law** for any violations of the State of Virginia Legal Codes.

### **Agreement:**

I hereby have read and agree to abide by all expectations of the above Fairfax Academy Parking Agreement and by signing below I give consent to a search of my registered vehicle by any authorized school employee, should suspicion of prohibited activity arise. I also understand the penalties if I should choose to ignore this Fairfax Academy Parking Agreement. All the information provided on the attached form is true to the best of my knowledge; any attempt to falsify information will result in the removal of parking privileges.
