**DESCRIPTION:**

- After-school activities include a variety of clubs, academic assistance, and recreation activities.
- Students will be provided a small snack and bus transportation home for bus riders on the days indicated. Late bus stops may differ from the regular bus stops.
- If a student needs to leave an after-school activity early, a parent/guardian must sign-out the student in the main office.
- The After School Program closes at 5:45PM Monday through Friday. Students must be picked up at this time or parents may be charged \$15 for each 15 minutes (or portion of 15 minutes) that the student is picked up late. Habitual lateness may result in the loss of services.
- Signing this form shows that you are aware of the after school program and its basic protocols and that you will allow your child to stay after school to participate. Your child is responsible for communicating with you in advance which days he/she will participate.

Continued participation in the After-School Program is contingent on the student's attention to school behavioral guidelines. Student participation in the After-School Program may be denied and parents may be asked to pick up their child if the guidelines, including chronic lateness to check-in, are not followed.

I agree that, to my knowledge, my child is physically and medically able to participate in these activities. If any injuries do occur to my child, I also understand that school personnel will respond in the same manner that occurs during regular school hours. I understand a late fee may be charged if my child is not picked up within 15 minutes of the program's end time and/or participation denied if my child is picked up late more than twice during the school year. In case of early closing due to inclement weather or emergency conditions, all after-school activities will be cancelled and all bus students will be sent home on their regular buses.
