

# Application Information for the Diploma Seal of Biliteracy 2023-2024

Students should fill out this form ONLY IF they are a current 12th grade student graduating in June or August of 2024 AND:

- Have not passed the FCPS World Languages Credit Exam OR
- Did not receive a rating of Meet Expectations on the final PALS in Level IV of a World Language (all components) OR
- Have not taken a World Language AP exam and received a score of three or higher OR
- Have not taken a World Language IB exam and received a score of four or higher

Students who HAVE met any of the above criteria will automatically receive or be noted as having the potential to receive the seal.

### **Criteria for Award**

The Board of Education of the Commonwealth of Virginia has established the Diploma Seal of Biliteracy to recognize language proficiency in English and a world language other than English, whether acquired in the classroom or at home. To earn the Virginia Board of Education Diploma Seal of Biliteracy you must satisfy the following three criteria:

- 1. Satisfy the requirements to earn a Standard Diploma or an Advanced Studies Diploma; AND
- 2. Pass all required End-of Course Assessments in English reading and writing at the proficient or higher level; AND
- 3. Demonstrate proficiency in a world language other than English, through one of a range of approved language assessment options at a level comparable to Intermediate Mid on the American Council on the Teaching of Foreign Languages (ACTFL) Proficiency Guidelines.

Assessment options for demonstrating proficiency approved by the Superintendent of Public Instruction include:

☐ Passing a world language AP examination with a score of three or higher; or
☐ Attaining a Level 3.0 or higher on the American Sign Language Proficiency Interview (ASLPI); or
☐ Scoring at the Intermediate level or higher on the Sign Language Proficiency Interview (SLPI:
ASL); or
☐ Scoring 600 or higher on a Latin SAT II test (SAT Subject Test)
☐ Receiving a rating of Intermediate Mid or higher on one of these exams:

<ul> <li>Modified Oral Proficiency Interview (MOPI); or</li> </ul>
<ul> <li>Oral Proficiency Interview by Computer (OPIc); or</li> </ul>
<ul> <li>Writing Proficiency Test (WPT); or</li> </ul>
<ul> <li>Standards-based Measurement of Proficiency (STAMP4S)</li> </ul>
☐ Scoring I-3 or higher on the Assessment of Performance toward Proficiency in Languages
(AAPPL); or
☐ Passing an International Baccalaureate examination with a score of four or higher; or
☐ Receiving a rating of B1 level or higher on an assessment authorized through the Common
European Framework of Reference for Languages (CEFR)
