Dear Parent or Guardian:

Each year, Fairfax County Public Schools (FCPS) is eligible to apply for federal Impact Aid grant funds. Impact Aid is a federal formula grant program designed to assist local school districts that enroll federally-connected students. Federally-connected students are children of active duty uniformed services personnel, children who live on federal property or in subsidized federal housing, and children whose parents are employed on eligible federal properties.

FCPS anticipates receiving approximately \$3,000,000 in unrestricted funds from the Impact Aid grant. These funds become part of the school system's general operating budget and are critical to maintaining high standards for educational excellence.

This year, FCPS is pleased to announce that the Federal Impact Aid Survey will be available electronically through your ParentVUE account. For families that do not have access to ParentVUE or prefer to complete a paper form, a printed form will be provided by your student's school.

We need your assistance in identifying students with federal connections to ensure that FCPS can obtain its fair share of funds from this program. Please complete the Federal Impact Aid Survey either electronically or by using the printed form, on the reverse side of this letter, for each school-aged student in your household. Printed forms must be signed and dated and returned to your student's school by November 17, 2023. Information provided will be treated confidentially.
