TO ALL PROSPECTIVE BIDDERS:

SUBJECT: Classroom Renovation Project at Belvedere Elementary School (MMB-089-24)

THE SUBJECT INVITATION FOR BID IS AMENDED AS FOLLOWS:

THIS ADDENDUM IS SUPPLEMENTARY TO THE PLANS AND SPECIFICATIONS FOR THE ABOVE SUBJECT REQUIREMENT. ALL CHANGES, ADDITIONS AND DELETIONS SHALL BECOME PART OF THE CONTRACT.

CLARIFICATION: The following questions were submitted, and the **combined answers** are provided as clarification to the Bidders.

- Q1. For the HVAC, the drawings mention an enclosure. Is this enclosure existing to remain? Is there supposed to be all new piping installed within that existing enclosure?
- A1. No. New piping from existing wall chase to new units.
- Q2. For the HVAC, the drawings show main piping out in the hallway. The unit piping appears to be installed overhead above the classroom, drops down a wall, then along the outside wall to the unit. On that topic:
 - 1. Are there shut off valves back at the main piping in the hallway?
 - 2. Are the only valves at the unit which is to be demoed? If so, this will cause the entire main piping run to be drained down, and upon completion, re-filled. Further, after re-filling/bleeding out air to whatever was drained, is there going to be additional pipes and units on the system?
 - 3. Are we to pipe to the first unit, tee, then continue on to the second unit? What will be allowed?
- A2. 1. Not none if valve exists in hall ceiling more than likely it does.
 - 2. No. No.
 - 3. Yes allowed.
- Q3. What is the earliest we can hand deliver our bid on June 4th.
- A3. You can hand deliver your bid beginning at 7:00 a.m.
