## **Alexandria City Public Schools**

- ACPS School Board launched the ACPS 2020 Strategic Plan: Every Student Succeeds in November 2015. This is the roadmap for the school division for the next five years. The Office of Communications won a National School Public Relations Association Golden Achievement Award for exemplary public relations for the launch of ACPS 2020.
- Over the last three years, ACPS continues to narrow the achievement gap by increasing the performance of all students while seeing the highest rates of improvement among historically under-performing subgroups in the content areas of reading, mathematics, and science.
- Charles Barrett Elementary School and Lyles-Crouch Traditional Academy were among 166 schools honored with the Board of Education Distinguished Achievement Award for 2016 in Governor Terry McAuliffe's Virginia Index of Performance (VIP) program.
- George Washington Middle School became one of only 600 schools in the United States to be designated a 'Model Program' by the American School Counselor Association.
- T.C. Williams High School celebrated its 50th anniversary graduation with a ceremony where the commencement address was given by U.S. Secretary of Education John B. King, Jr.
- ACPS has earned the 2016 Annual Achievement of Excellence in Procurement Award from the National Procurement Institute, Inc. (NPI). It is the first time that ACPS has received this highly regarded distinction.
- ACPS Superintendent Dr. Crawley was presented with the 2016 Education Leadership Award. He was acknowledged for his commitment to students, his excellence in education and his involvement in the community in promoting education.

- APS is the recipient of the prestigious Medallion of Excellence Award present by the U.S. Senate Productivity and Quality Awards for Virginia and the District of Columbia.
- All schools are accredited by the Virginia Department of Education according to state accreditation ratings and federal accountability ratings.
- The 2016 *Washington Post* Challenge Index listed all APS high schools in the top 3% in the U.S. This is the seventh year in a row all APS high schools made the list.
- 10 APS schools received 2016 Virginia Index of Performance awards for advanced learning and achievement.
- Every APS preschool slot funded with state dollars is matched and filled with a student.
- Spanish immersion programs are offered at two elementary, one middle, and one high school.
- In 2015-16, 82% of middle school students were enrolled in an Algebra I or Geometry course.
- More than 95% of APS students earn one or more high school credits during middle school.
- Approximately 75% of graduating seniors completed at least one AP or IB course, and 66% of graduates earn an advanced diploma.
- In 2016, 91.1% of all students graduated on time.
- Since 2010, the dropout rate has declined by almost two-thirds, or 65%.
- In 2016, 93% of APS parents graded the school division as an "A" or "B," and 94% gave their child's school an "A" or "B."
- 79% of APS teachers have earned a master's degree, and 3% have earned a doctorate degree.
- Arlington ranks third in Virginia and 28th nationally with 162 teachers, or approximately 6.8%, who have earned National Board Certification.
- Niche.com ranked APS as the top school division in Virginia and 44th in the nation. Sixteen APS elementary schools topped the list of the best public elementary schools in Virginia. APS elementary schools were also ranked 18-20 and 22nd.
- Improved academic performance increases local property values by \$2.7-\$4.7 billion, resulting in added property tax revenue of about \$27-\$47 million annually.

## **City of Fairfax Public Schools**

- Since 1962, the City of Fairfax School Board has contracted with Fairfax County Public Schools (FCPS) for the delivery of educational services. The City School Board owns and is responsible for its school buildings. Students in city schools have access to the same programs as are provided in all Fairfax County Public Schools.
- The City of Fairfax School Division is comprised of four buildings housing some 5,500 students in grades PreK-12. About 3,100 of these students are residents of the City of Fairfax, with the remainder residing in Fairfax County.
- City of Fairfax Schools include:
- Daniels Run and Providence Elementary

Daniels Run and Providence elementary schools completed major renovations in 2000. Both schools provide a state of the art instructional environment, with technology available as a tool for learning. Both schools have additional resources to support a focus on mathematics, science, and technology. These schools are among the first in the region to offer world language instruction to all students. Each school has a capacity of about 800 students.

• Lanier Middle School

Lanier Middle School, often recognized for the rigor of its academic program, completed an extensive renovation in the spring of 2008. The renovated school provides a technology rich learning environment, as well as superior facilities for instruction in physical education and the arts. The capacity of Lanier is approximately 1,200 students.

• Fairfax High School

Fairfax High School, renovated and rededicated in the fall of 2007, is an academic and arts showcase. Offering students a challenging academic program, including a full range of AP courses, as well as the specialized programs of the Fairfax Academy for Communication Arts, graduates are fully prepared for their futures; approximately 90 percent continue their educations in post secondary institutions. The capacity of Fairfax High School is 2,400 students.

## **Fairfax County Public Schools**

- Fairfax County Public Schools (FCPS), the nation's 10th largest school division, inspires and empowers students to meet high academic standards, lead healthy, ethical lives, and be responsible and innovative global citizens.
- The FCPS Strategic Plan, Ignite, provides a framework for decision making that builds upon a common mission, vision, and guiding principles held by the community. The Portrait of a Graduate is the center of the Strategic Plan.
- Based on the 2016 *Washington Post* rankings, of nearly 2,300 top U.S. high schools, all Fairfax County high schools have been designated among the most demanding public schools in the country and two schools ranked within the top ten percent of high schools nationally.
- Thomas Jefferson High School for Science and Technology (TJHSST) was ranked by *U.S. World and News Report* in 2016 as the number five gold medal school. Additionally, TJHSST was ranked number three for the best STEM school. In total, FCPS received twelve gold medal awards, one of which was ranked in the top 100 high schools nationally, and four silver medals.
- Twenty-six FCPS schools received the 2016 Board of Education Excellence Award, recognition of schools and divisions that have met all state and federal achievement benchmarks and have made significant progress toward goals for increased student achievement and expanded educational opportunities.
- Twenty-three FCPS schools received the 2016 Board of Education Distinguished Achievement Award. Eight Virginia schools, including three FCPS schools, received the Governor's Award for Educational Excellence.
- Ninety-four percent of FCPS schools, compared to 81 percent statewide, earned full state accreditation from the VDOE based on the results from the Virginia SOL tests administered during the 2015-2016 school year.
- Fairfax County Public Schools' 2016 SAT average of 1672 exceeds both the state (1522) and national average (1453).
- FCPS was named one of 15 first place award winners in the National School Boards Association 2016 Magna Awards competition for its program on the FY 2017 Budget that solicited community feedback and sought to provide the public with a voice in the budget process.

- A small, independent, city school division since 1949.
- Five schools fully accredited. Each school specializes in specific grade levels:
  - Jessie Thackrey (PreK, Special needs preschool and family literacy programs)
  - Mount Daniel Elementary (K-1)
  - Thomas Jefferson Elementary (2-5)
  - Mary Ellen Henderson Middle (6-8)
  - George Mason High (9-12)
- Consistently ranks among the top school systems in the region and nation in analyses conducted by the *Washington Post* and *US News and World Report* magazine.
- One of only two division in Virginia to receive the 2015 Virginia Index of Performance Board of Education Excellence Award
- Consistently recognized for excellence by the Virginia Department of Education and the U.S. Department of Education.
- Consistently scores above state and national averages on standardized tests. 2015 FCCPS SAT average of 1766 exceeds the state average of 1523 and the national average of 1487.
- On-time graduation rate: 100% (2015 & 2016)
- 92 percent of graduates seek post-secondary education, primarily in four-year colleges and universities.
- Student body is multi-cultural. In 2015, the number of native languages spoken by students was 39.

## **Loudoun County Public Schools**

- Loudoun County Public Schools (LCPS) opened Madison's Trust Elementary School, bringing the total number of its schools to 89. The LCPS projected enrollment is 78,665 as compared with 75,755 a year ago.
- Since the beginning of the 2000-2001 school year, LCPS has opened 45 schools: 26 elementary, nine middle schools and 10 high schools. All have opened on time and on budget.
- LCPS has 14 Schools to Watch, as determined by the National Forum to Accelerate Middle Grades Reform, the most of any jurisdiction in America.
- Two LCPS middle schools Farmwell Station and J. Michael Lunsford are among only eight Virginia schools to win the 2016 Governor's Award for Educational Excellence, the highest award under the Virginia Index of Performance (VIP).
- All of the 13 LCPS high schools eligible to be ranked nationally by *The Washington Post's* Most Challenging Schools received this honor in 2016.
- The Loudoun County Public Schools Class of 2016 received a record \$59,476,537 in scholarships.
- Dominion High School has been awarded the Claudia Dodson Sportsmanship, Ethics and Integrity Award from the Virginia High School League (VHSL) for the 2015-2016 school year. It is the third time the school has been recognized with this honor
- Loudoun County Public Schools School Nutrition Services received a "One in a Melon" Award from the United States Department of Agriculture (USDA) for its efforts to bring fresh, local produce to the students eating in school cafeterias each day.
- Loudoun Valley High School was named one of five Grand Prize Winners in the Samsung Solve for Tomorrow Contest. Loudoun Valley received \$120,000 in technology equipment from Samsung as a part of this honor.
- The U.S. Environmental Protection Agency awarded Liam McGranaghan of Loudoun Valley High School with the Presidential Innovation Award for Environmental Educators.

## **Manassas City Public Schools**

- Osbourn High School is a Grammy Signature School in music education and was identified in 2016 as a Silver Medal School by US News and World Report, placing it in the top 16% of high schools in Virginia.
- MCPS theme schools include Weems Elementary School, which holds national recognition for its high achievement as an urban school and is a "Visitation Viable" model school for its TAG (Talents & Gifts) program. Haydon Elementary School features a Spanish Dual Immersion program that began in the Fall of 2016 with the school's Kindergarten classes.
- Early learners are afforded the opportunity to participate in the Virginia Pre-School Initiative through a traditional or blended learning program. Through Model Innovation City© all Pre-K through 3rd grade children who live in the City of Manassas have free access to the Footsteps2Brilliance literacy software.
- MCPS offers the only Integrated Math and Science Program (7-10) and Integrated Humanities Program (7-12) to students in the region.
- Algebra 1, World Language, and Honors Earth Science and Geometry are offered at the middle school level for high school credit.
- Robotics, VEX, Sea Perch, and "It's Academic" teams promote high level independent thinking and essential teamwork skills. Project Lead the Way is offered in grades 5-12.
- Students in grades 9 -12 participate in a 1:1 blended learning environment that supports creativity, collaboration, critical thinking, communication, and responsibility.
- Students begin foreign language study in middle school.
- Band, Orchestra and Guitar are offered beginning in 5th grade.
- A K-12 CTE & STEM program is offered in all schools.
- MCPS students can attend the Governor's School @ Innovation Park which offers advanced college level STEM courses to juniors and seniors on the Prince William Campus of George Mason University.
- George Mason University and Northern Virginia Community College provide opportunities for students to experience college level academics and obtain college credit, while in high school.

## **Manassas Park City Schools**

- The MPCS tradition of excellence emerging with a path of innovation to transform teaching and learning by embracing a blended learning model for all students. Phase III of the MPCS 1:1 environment provides individualized learning for grades 5 through 12 and incorporates the 4 C's (Creativity, Critical Thinking, Communication/Compassion, and Collaboration) in order to educate students to be global learners.
- Extreme Networks recognized MPCS with the Exemplary School Award for Commitment to Personalized 21st Century Learning Environment.
- MPCS continues the Balanced Calendar that began in the 2015-2016 school year; maintaining the 180-day calendar, but with a balanced approach that provides frequent enrichment, remediation and breaks.
- All students grades K-12 are provided opportunities to participate in STEM education. These programs are supported by The BELL Foundation, the education foundation for Manassas Park.
- The Early Identification Program (EIP), in partnership with George Mason University, has 44 MPCS student participants. The program promotes higher education to potential first generation college students.
- MPCS adopted, practices and continues to train their staff on ALICE Alert, Lockdown, Inform, Counter, and Evacuate – a set of proactive strategies that moves beyond lockdown and increases the chance of survival during a violent intruder event.
- The city's diversity extends into the school system where students speak over 40 different languages at home.
- Located at the Manassas Park Community Center the Mason and Partners Clinic (MAP) – a partnership between MPCS, George Mason University, and surrounding health care providers was established to serve the medical needs of the uninsured.
- MPCS enters the third year partnering with the Capital Area Food Bank. The partnership distributes over 70,000 pounds of food to families during the school year. Staff members from all four schools, administration, and the City of Manassas Park come together at Manassas Park High School and volunteer their time to organize and distribute food to families. MPCS was recognized at the 2016 Raise the Region Gala Event held by the Community Foundation for Northern Virginia for these efforts.

## **Montgomery County Public Schools**

- Two MCPS high schools rank in the top 100 of *The Washington Post* 2016 High School Challenge. Eight MCPS schools rank in the top 20 Washington area and Maryland schools.
- 13 high schools made the *U.S. News & World Report* 2016 list of Best High Schools. Eight MCPS schools received a gold medal for being among the top 500 schools in the nation.
- According to Education Week, MCPS has one of the highest graduation rates among the nation's largest districts. The Schott Foundation reports that MCPS has the highest graduation rate in the nation for African American males in the nation's largest districts.
- A total of 33,554 AP exams were taken by MCPS students in 2015. Students earned a score of 3 or higher on 74% of the exams.
- In 2015, the percentage of African American and Hispanic graduates earning a 3 or higher on at least one AP exam surpassed the state average.
- The Class of 2015 earned a 1629 average combined SAT score, surpassing both national and state averages. Sixty-seven percent of graduates took the SAT and MCPS' Hispanic and African American students outperformed their peers across the nation.
- More than \$343 million in scholarships were awarded to MCPS students in the Class of 2016.
- 52% of Grade 8 students completed Algebra 1 with a "C" or higher in 2015.
- MCPS received the 2010 Malcolm Baldrige National Quality Award, the highest presidential honor given to American organizations for performance excellence. MCPS became only the sixth public school system to receive the award and is by far the largest school district to be a recipient.
- In 2010, MCPS was named one of 5 finalists for the prestigious Broad Prize for Urban Education, the largest education prize in the country. MCPS was chosen as a finalist from a pool of 100 school districts.
- MCPS leads the state with more than 700 teachers certified by the National Board for Professional Teaching Standards, a national recognition of professional excellence.

- PGCPS is nationally recognized for its innovative programs and initiatives, including the Academy of Health Sciences Middle College, expansion of career academy course offerings, and partnerships with businesses and institutions of higher learning. It is our mission to advance the achievement of its diverse student body through community engagement, sound policy governance, accountability, and fiscal responsibility.
- Building on significant academic progress, the Board of Education reconciled and approved a \$1.9 billion operating budget on June 14, 2016, an increase of \$82.2 million. This budget will expand prekindergarten offerings, aerospace engineering, aviation tech and career academy programs, increased focus on early literacy and numeracy efforts and the Parent University designed to engage parents in their child's education. Additional resources were added to meet compliance requirements associated with mediated settlement agreements, cover mandatory costs of conducting school business, as well as funding to support Student-Based Budgeting to all schools.
- The FY 2017 Operating Budget approved by the Board includes a net increase in State Aid of \$48.9 million, primarily due to adjustments in state aid programs. County funding, including both the telecommunications and energy tax estimates, totals \$698.3 million, an increase of \$29 million from FY 2016. The County met its Maintenance of Effort obligation by \$18.9 million.
- The FY 2017 approved Federal funding decreased by \$6.3 million, due to a decrease in the federal restricted grants, including the sunsetting of the Race To The Top funds. Board sources amount to \$13.3 million, which is a decrease primarily due to a decline in tuition revenue and restricted board sources.
- The FY 2017 approved expenditure budget was focused on four key strategic plan initiatives: 1) Academic Excellence; 2) High Performing Workforce;
  3) Safe and Supportive Environments; and 4) Family and Community Engagement; 5) Organization Effectiveness. Supporting these areas required the system redirect over \$12.3 million of existing resources.
- The FY 2017 Operating Budget supports our promise of "Outstanding Academic Achievement for All Students," and our mission "to provide a great education that empowers all students and contributes to thriving communities."




